The purpose of this study was to explore the influence of psychological, behavioral, and physical factors on women's substance use. To address this purpose, the authors developed a survey instrument consisting of a demographics questionnaire, measures of the psychological, behavioral, and physical aspects of drug use, and questions assessing attitudes and beliefs about the use of drugs. The survey was distributed to 105 women during routine prenatal visits at a hospital in rural western North Carolina. Women were predominantly African American and poor. Most women in the sample (52.4%) reported that they had used alcohol within the past 30 days, and 21.4% reported an alcohol use disorder. Only one third of the sample (34.3%) reported being currently pregnant. Multiple logistic regression models indicated that vulnerability to drug use was associated with rural status and history of abuse. In turn, the data suggested that a majority of the women in the sample (81.0%) rated alcohol use as not beneficial to a pregnant woman. The authors conclude that vulnerable women living in rural communities may be unaware of the dangers of alcohol and drug use during pregnancy. To begin to address this potential problem, providers of prenatal care in rural areas should address alcohol and drug use during their counseling efforts.Q: Why are

Because the arbitration clause in the contract does not encompass this type of dispute, it is not subject to arbitration. It is also unlikely that the union would initiate the arbitration process. Plaintiff's complaints of harassment and negligent supervision also fail to fall within the arbitration clause of the current collective bargaining agreement. The union's complaints of harassment and negligent supervision concern alleged incidents of racial discrimination, not alleged violations of the collective bargaining agreement. The Union has not shown that these particular claims are subject to arbitration. 3. Retaliation Plaintiff alleges that he was retaliated against by both defendants when he complained that he had been wrongfully terminated. There is no arbitration clause which covers such claims. Thus, the court concludes that neither defendant is bound to arbitrate the issue of retaliation. 4. Sabotage Plaintiff alleges that his termination was the result of sabotage by Union President James O'Brien. Defendants do not contend that the underlying claim is subject to arbitration. They argue, however, that the cause of action is at least partially time barred because plaintiff filed this action in May 1984. Plaintiff did not assert that he had a cause of action for sabotage until December 1985. Plaintiff, however, is not time barred. The NLRB has jurisdiction over the question of employee conduct by other than union agents. 29 U.S.C. § 152(3); see NLRB v. Viola Industries-Erie, Inc., 937 F.2d 824, 831 (3d Cir.1991). Plaintiff's sabotage claim against O'Brien is not time barred. It is also against the Union for the same reasons discussed above. 5. Failure to provide required vacation pay Plaintiff alleges that he was not provided vacation pay which he was entitled to under the contract. An employer must pay vacation benefits to an employee who is properly "terminated... with cause." 29 U.S.C. § 2104(a)(1). Under the terms of the collective bargaining agreement, an employee is entitled to four weeks vacation with pay after one year of employment. The employer must pay for this time at the rate of one week's pay for each year of service. (Def.Ans.11.) Plaintiff is therefore entitled to \$4,000.00 in back vacation
